Time – 7:00-10:00 pm Dancers need to arrive between 5:30 and 6:30 for check in.

Dancing in the Dance-a-Thon. In the spirit of the marathon concept, all dancers will be encouraged to dance as much as possible for the full three hours. You can dance with anyone at Sundance Saloon, not just other dance-a-thoners. We do recommend a two-song break every half-hour. (If you don't do line dances, these would be a natural break for you.) The tags that you will be wearing will have a system that will make it easy to see who is a lead, a follow or "versatile." And if you don't make it through the entire three hours, the point is that you tried.

Minimum Fundraising Amount. We ask that you raise a minimum of \$50. Don't worry! This is not hard to raise – just ask four friends for \$15 and you have already exceeded the required amount! We are purposely keeping the minimum low, to encourage lots of participation, but we would be disappointed if we didn't see some higher amounts! At the end of the event we'll have a special acknowledgment for the largest fundraisers of the Dance-a-Thon.

Who do I get to pledge money? – Friends, family, co-workers, ex-lovers ... anyone you think of who can spare a few bucks or many to support some worthy causes.

How can they pay? – There are three ways to pledge money. It's a good idea to get a 9"X12" manila envelope to keep all of your paperwork and pledges in.

- Cash Easy and painless! Please fill out the pledge sheet and keep the cash in your pledge envelope.
- Check Please have the check made out to "AIDS Emergency Fund." Keep track on your pledge sheet, and keep the check in your pledge envelope.
- Credit Card Use the credit card payment form. The AIDS Emergency Fund accepts only Visa and MasterCard.

Who are the beneficiaries? – It will be easier for you to ask for donations if you know something about the beneficiaries. Three organizations will share the proceeds from the Dance-A-Thon:
